*Application requirements:*

- Abstract (250 words) describing the clinical case to be presented.
- Clinical case information must be stripped of identifying information.
- Clinical case must not be identifiable from the media.
- Student must have supervisor's permission to present the clinical case.

*Requirements:*

- Must be a current graduate or undergraduate student
- Presentation will be a maximum of 5 minutes.
- Must be research that will not be presented again at the 2024 ATSA conference.

*Application requirements:*

- Abstract (250 words) describing the research to be presented (please include title).
- Student must have supervisor's permission to present the research (see attached form).
